Subject: **GRIEVANCE ON TECHNICAL EVALUATION AND VIOLATION OF PPRA RULES IN PROCUREMENT OF LIQUID WASTE MACHINERY IN MUNICIPAL COMMITTEE GOJRA.**

Reference is made to tender documents issued by MC Gojra in favor of Colibrative Heavy Industries Pvt Ltd JV Fuso Master Motors Pvt Ltd.

During technical opening of tender, it was announced by the procurement committee that one of the bidder M/s Meraj Limited quoted truck chassis model Isuzu NPR Turbo Charged only. Kindly note that the tender specifications issued by the department, required truck chassis to be equipped with "Turbo Charged with Intercooler as mandatory". Copy of tender specification attached as Annexure-A and Copy of Isuzu NPR Model brochure attached as Annexure-B for comparison. Hence, the bid with above quoted chassis cannot qualify as per the tender documents, but we were astonished to see that not only was that company wrongly qualified but also invited for financial bid opening as well. Therefore, we request the department to halt the ongoing process and re-evaluate the technical bid as per given criteria in tender to avoid misprocurement.

Furthermore, the technical evaluation report was not uploaded on the PPRA's web site before financial opening, which is in violation of qualification procedure as mentioned in chapter-IV (8)(d) of the PPRA Rules.

Thus, we are submitting our grievance according to chapter-X (67)(2) of PPRA Rules, so that the Department may take just action against the low spec truck chassis (Isuzu NPR) and proceed with the procurement process in accordance with the PPRA Rules 2014 as amended time to time.

In pursuance of constitution of Grievance Redressal Committee under "Punjab Cities Programme" by Administrator MC Gojra / Assistant Commissioner Gojra vide No. 1908 dated 28-07-2022, 2nd meeting of grievance committee was held on 29-09-2022 in the office of Deputy Director (Dev.) T.T.Singh to readdress the grievances / issues arising between contractor and procuring agency i.e. Municipal Committee Gojra during of implementation of "Punjab Cities Programme" in Gojra. The meeting was attended by the following participants:

- iii. Municipal Officer (Regulation) MC Gojra (Member)
- iv. Mr. Mudassar Ashraf DPO (ID) Punjab Municipal Development Funds Company
- v. Mr. Noor, Regional Manager, Meraj Innovative Engineering
- vi. Mr. Saad Ashfaq, Solar & Service Engineer, Meraj Engineeriong

2. Meeting was started with the recitation of Holy Quran. Opening the discussion, the convener welcomed the participants and directed to proceed with as per agenda. Municipal Officer (Regulation) referred to the discussion held during meeting of grievance committee held on 27-09-2022 and briefed that the purpose of the meeting is to discuss / decide the grievance filed by one of the bidder M/s Colibrative Heavy Industries (Pvt.) Ltd (CHIL) vide No. CHIL/MC-G/22-23/A0082 dated 15-09-2022 while extending an opportunity of hearing to bidder M/s Meraj Innovative Engineering and to seek viewpoint of Punjab Municipal Development Fund Company.

3. The representative of M/s Meraj Innovative Engineering explained to the grievance committee that their company quoted technical and financial proposal as per requisite specifications provided in the tender document issued by procuring agency regarding procurement of Machinery for Liquid Waster & Aerial Platform for Gojra City. He furthered that company has clearly mentioned in the bidding document regarding compliance with the requirement of Turbo Charged with Intercooler. The company further submitted the undertaking to supply the machinery to be procured under said advertisement, while fully complying with specifications of the bidding documents.

4. The representative of Punjab Municipal Development Fund Company (PMDFC) agreed to the viewpoint of M/s Meraj Innovative Engineering and suggested that the lowest bidder should submit the undertaking regarding compliance with the requirements / specifications mentioned in the bidding documents.


5. After detailed discussion / deliberations, perusing the relevant record, assessing the statements / viewpoints of all the stakeholders and consulting relevant rules, the grievance committee unanimously decided to reject the stance of aggrieved firm and to go ahead with the tendering process regarding award of work to the lowest qualifying bidder strictly in accordance


with PPRA Rules 2014. The committee further decided that affidavit / undertaking may also be sought from lowest bidder for supply of machinery / equipment strictly in compliance with the requirements / specifications mentioned in the bidding documents.
